In line with Corporate Disclosure requirements, we wish to inform that, NTPC has decided to issue unsecured non-convertible debentures of Rs.4,000 crore on 20.03.2025, through private placement at a coupon of 7.26% p.a. for a tenor of 15 years, maturing on 20.03.2040, under the board resolution dated 29.06.2024 and subsequent approval obtained through shareholders' resolution dated 29.08.2024.

This is the first issue of debentures under the above mentioned approval.

Proceeds will be utilized for, inter alia, funding of capital expenditure, refinancing of existing loans and other general corporate purposes.

The debentures are proposed to be listed on NSE.
