The figures for the quarter and nine month ended 31 December 2025 have been subjected to limited review by the statutory auditors. The auditors have expressed unmodified opinion on the limited review reports for the quarter and nine month ended 31 December 2025.
3. The Company's management, pursuant to 'Ind AS 108 - Operating Segments' has concluded that the Company has only one reportable segment which is Specialty Chemicals. Accordingly, no separate disclosures of segment information have been made.
4. During the previous year, the Company sold its tenancy rights to a property situated in Mumbai for a total consideration of ₹ 153 lakhs, which has been recognized as an exceptional item in the financial statements.
5. On November 21, 2025, the Government of India notified the four Labour Codes - the Code on Wages, 2019, the Industrial Relations Code, 2020, the Code on Social Security, 2020, and the Occupational Safety, Health and Working Conditions Code, 2020 - consolidating 29 existing labour laws. The Ministry of Labour & Employment published draft Central Rules and FAQs to enable assessment of the financial impact due to changes in regulations. The Group has assessed and disclosed the incremental impact of these changes on the best information available and consistent with the guidance provided by the Institute of Chartered Accountants of India. Considering the regulatory-driven and non-recurring nature of this impact, the Group has presented such incremental impact under Exceptional Items amounting to ₹ 20, lakhs in the consolidated financial results for the quarter and period ended December 31, 2025. The Group continues to monitor the finalisation of Central / State Rules and clarifications from the Government on other aspects of the Labour Code and would provide appropriate accounting effects on the basis of such developments as needed.

# FIR against IPS officer for 'illegally detaining' Nigerian man in 2023

New Delhi, February 6

THREE YEARS after a Nigerian man was allegedly illegally detained from Delhi's Dabri, an FIR has been filed against 2011-batch IPS Officer Shankar Choudhary, who was posted with the Mizoram Police, in connection with the case.

As per the FIR filed by the Delhi Police Vigilance Unit on Thursday, following an enquiry, Choudhary allegedly misused his official authority and illegally detained the Nigerian national without following legal procedure.

It also claimed he carried out an inter-state police operation without informing authorities or seeking prior approval. *The Indian Express* reached out to Choudhary via text messages seeking comment. A response is awaited.

As per the vigilance FIR, a PCR call was received from a woman in Nigeria, on November 29, 2023, claiming that her

brother had been arrested by the Mizoram Police. She alleged that Rs 35 lakh was taken for his release, with a further demand of Rs 20 lakh being made.

The woman allegedly named Choudhary as the officer involved in the detention and extortion. On July 22 last year, the Ministry of Home Affairs (MHA) had asked the Delhi Police to look into the allegations against Choudhary. The Delhi Police Commissioner then appointed an enquiry officer to ascertain the facts.

As per the FIR, on November 26, 2023, Choudhary and Delhi Police staff entered the residence of the Nigerian man, Harrison, at 3.34 am. The team left at 5.40 am, taking a locker and two bags.

The seized items were not recorded in police records of either Delhi or Mizoram Police, the FIR claimed. It also said CCTV footage showed Harrison was taken from his resi-

dence by Choudhary's team. He was then kept at Mizoram House from November 26 to 29. There was no arrest memo, court production, or legal order during this period, the FIR claimed.

As per the findings of the enquiry, Choudhary stayed in Delhi after his approved leave ended on November 20, 2023. There was no written or formal communication between Mizoram Police and Delhi Police allowing these raids.

No official diary entry, written order, or wireless message exists in Delhi Police records to authorise these actions, the FIR claimed.

From this, the FIR stated, two head constables, though officially posted elsewhere, acted as Choudhary's driver and assistant without written orders. Their involvement was beyond their official duties and amounted to serious misconduct for which departmental enquiry would be conducted, it said.

# HC sets aside student's punishment with placard

SETTING ASIDE a direction to a student to stand outside a university in Noida for 30 minutes over 30 days, with a message on a placard that he will never misbehave with any girl, the Allahabad High Court said it was unjustified and uncalled for.

"It is not only humiliating but would cast a permanent scar on the character of the appellant," said the division bench led by Chief Justice Arun Bhansali, also comprising Justice Kshitij Shailendra, in its order Wednesday while setting aside the direction by a single bench of the HC.

The appellant, who is pursuing a BSc in Medical Laboratory Technology (BSc MLT) degree at Noida International University, had been rusticated on March 30 last year for allegedly misbehaving with women

students of another university.

The varsity had claimed to have video recordings to justify its rustication decision.

The student had challenged his rustication through a petition in the HC. On October 29 last year, a bench of Justice Saurabh Shyam Shamshery had issued an order setting aside the rustication — with conditions and directions.

The single bench had observed, "On the basis of material produced by the...counsel for respondent-university, the conduct of the petitioner appears to be not bona fide...even his attendance is less than 50% in earlier academic years."

It had further stated, "...due to his misconduct, he has been rusticated from Noida International University. The nature of misconduct is serious, i.e., misbehaving with girl students of [another] university and bunk [bunking] classes along with...

3 cops face action after video of 'misbehaviour' with lawyers surfaces online

THE DELHI Police on Thursday initiated disciplinary action against the Station House Officer (SHO) of Sagarpur police station following protest calls by city lawyers after a purported video surfaced on social media showing police personnel allegedly using "derogatory" language against advocates.

In the video, policemen were purportedly seen attempting to stop the entry of a lawyer into the station. After this, the Coordination Committee of District Court Bar Associations called for a protest at Sagarpur police station.

A communication from the office of the Deputy Commissioner (Southwest) Amit Goel read: "...in the present matter (viral video), a vigilance enquiry has been initiated...and action has been taken against the erring police personnel... one [woman] SI has been placed under suspension and one [woman] SI along with SHO, PS Sagarpur, have been sent to District Line/Southwest District with immediate effect...."
