



## Mahadevapura and 'vote chori' charge

rolls of Mahadevapura for the 2024 Lok Sabha polls were dubious — either because the names were registered in multiple constituencies, or had fake addresses, or had submitted invalid photographs at the time of registration.

One of the charges made by him was of "bulk voters at a single address", mentioning 10,452 allegedly in such category — including 46 voters at House No. 791 in Marathahalli Booth No. 366: 68 at House No. 153 (at brewery 153 Biere Street) in Vinayaka Nagar Booth No. 243; and 80 voters at Garden Booth No. 470.

The Indian Express visited the above three addresses mentioned by Gandhi, and found that each corresponded with spaces where a large number of migrants live or work. However, none of the 194 people whom Gandhi mentioned as staying at these addresses with names in the electoral rolls now lives there, as per the caretakers or managers.

The Mahadevapura constituency was won by the BJP in the 2023 Assembly polls and also facilitated the party's win in the Bangalore Central Lok Sabha seat in the 2024 Lok Sabha elec-

#### **House No. 791**, Marathahalli: 46 voters

Locating the address, falling on '5th Main Road', in an area behind the now demolished Tulasi Talkies in Marathahalli, is difficult. The buildings here, serving as paying guest facilities, food canteens or low-cost restaurants for migrants – from those starting at the lowest rung in IT companies to gig workers — don't sport any numbers upfront.

An elderly couple who have been residents for 30 years at a House No. 791, also on '5th Main Road', reveal that a paying guest facility called Akshaya PG for men operates from a building also called House No. 791.

Running now for over a decade, the Akshaya PG has 25 rooms which can house 75 people at a time. The place is popular mainly with Telugu-speaking workers employed in food deliverv services, on account of its owners and caretakers being Telugu speakers, who offer Andhra food. A 2020 electricity bill for the building housing Akshaya PG suggests the owner is Nagaraja Reddy.

The online listing for Akshaya PG identifies it as a 'Boys Hostel', located at 791, 5th Cross Road of Marathahalli village, charging Rs 4,500 per month without TV and Rs 5.000 per month with TV. "Best for Andhra people" says an online review from 2018.

Of the 46 names listed by Gandhi as registered to House No. 791 in the 2024 Lok Sabha polls list, the Akshava PG caretaker, Madhav Rao, says: "None of them lives here any more. They all moved out during Covid.

The bench asked if the potential for misuse can be a ground to strike down a provision. "Any provision in penal law can be misused..." Justice Kant observed.

"How can it be statically defined that what will be an act of endangering sovereignty? For instance, one can argue that political dissent can't endanger sovereignty... Inviting the legislature to define 'endangering sovereignty' is a big danger," Justice

Kant said Mehta said that a new "nega-

tive explanation" had been in-

We see a lot of paying guests. Some stay for a couple of months, others for about a year. Very few stay for long periods." Incidentally, a majority of the

in and out here. Some of them obtain voter ID cards to secure employment," says a tailor at a small store located next to Akshaya PG. "I have a house with three

rooms that has been rented out to a hotel group. Twenty people live there. The presence of many voters at the same address does not necessarily mean fake votes," says Mohan Kumar, a local store

### House No. 153, Vinayaka Nagar: 68

Property number 153 is located in the Whitefield area of Bengaluru, with a Europeanstyled brewery called '153 Biere Street', spread over more than an acre, running from its premises. The property also has a small shopping plaza, with several lux-

Speaking about the number of voters registered at House No. 153 in the electoral roll, Gandhi said: "68 voters in 153 Biere Club. Can 68 people really live in a

Two separate managers at the brewery suggest that the names may be of former workers at 153 Biere Street. "None of these people are working here now. The management has recently changed and most of the staff are new," Suraj, one of the managers, says.

"We are a commercial establishment and we do not give out voter ID cards. We ask staff for Aadhaar and PAN as proof of identity," adds Praveen V, the general manager of the brewery.

#### House No. 35, Munireddy Garden: 80

Munireddy Garden is located at the end of a small road, a short distance from the sprawling Ecoworld and Ecospace tech parks. A majority of the properties here are in the names of local landlords from the Reddy community of Andhra Pradesh and many have been converted into paying guest facilities or have rows of single rooms rented

out to migrant workers. House No. 35 lies at the end of a row of 35 houses owned by Jayaram Reddy, all rented to migrant workers. The tiny rooms with attached toilets can accommodate two-three persons each and are rented out for Rs 3,000

The current tenant at No. 35 is a migrant worker from West Bengal, who has been living at the facility for two months. His name does not figure in the Mahadevapura voters' list as he arrived only recently, says caretaker Suresh Kumar, who lives

"We do not know why there are 80 names in the voters' list for House No. 35 alone. We have a high churn of people renting and leaving the rooms. Many of the names in the 2024 voters' list are of people who lived here before Covid. The place emptied out during Covid," says the care-

According to the caretaker, the tenants need a copy of the electricity bill and an ID for employment.

Local BJP leader and former Mahadevapur MLA Aravind Limbavali told The Indian Express: "We checked and found that only six among the 80 voters listed at House No. 35 actually

About Gandhi's claim regarding House No. 153 in Vinayaka Nagar, he said: "Sixty-eight workers are shown as voters at the address since they were given common accommodation at a dormitory. Only two of the 68 voted in the 2024 polls... All of Rahul Gandhi's allegations are far from the truth. No illegalities have occurred in Mahadevapura. We won legitimately. Our party has seen natural growth. Rahul Gandhi should realise this."

#### A changing Mahadevapura

On paper, Mahadevapura appears to have seen an unnatural growth in voter numbers, from 2.75 lakh in the 2008 Assembly elections to 6.6 lakh in the 2024 Lok Sabha polls, an increase of 140%. The Assembly segment in Bangalore Central with the second-highest increase in electorate, Sarvagnanagar, saw only

The growth of voters in other Assembly segments of Bangalore Central was in the same range – Shanti Nagar 25.2%; C V Raman Nagar 23.1%; Shivajinagar 19.8%; Rajaji Nagar 13.7%; Chamrajpet 12.6%; and Gandhi Nagar 3%.

At the same time, the number of properties in Mahadevpura more than doubled between 2016-17 and 2023-24 – from 1.48 lakh to 3.59 lakh. The region now contributes Rs 885 crore in tax revenues to the city, compared to Rs 361 crore in 2016-17. In addition, the region has 1.5 lakh properties under gram panchayats.

The BJP has won the Mahadevapura Assembly and Bangalore Central Lok Sabha seats on all four occasions since the new Mahadevapura constituency was created in 2008. Like in 2024, the Lok Sabha poll win for the BIP in Bangalore Central in 2019 was facilitated by the huge leads the party secured in Mahadevapura, despite losing

ground in other segments. In the 2024 Lok Sabha polls, BJP votes in the Mahadevapura segment increased by 47,901 from the 2023 Assembly elections; the Congress's dipped by

village in Pratapgarh, UP. "Writing on the back of the bib was my way of a tribute to my father who passed away in 2018 because of an ailment. My father drove a truck. I miss him,' Shahnavaz told *The Indian Express* on Tuesday. The 8-metre mark, like the 80-metre mark in men's javelin, is a benchmark which separates the wheat from the chaff.

"I wanted to cross the 8-metre mark desperately. I jumped 7.90 metres in my last competition, so I knew I was close to the 8-metre mark," Shahnavaz said. He didn't appear to be overawed by the occasion as he raised his arms over his head and exulted while facing the spectators at the stadium.

This wasn't a flash in the pan

performance by Shahnavaz, a consistent performer at the agegroup level. In December, he became the Under-18 national champion with a jump of 7.72 metres and at the start of the year he won the National Games gold with 7.70 metres. He also has Sreeshankar to thank for prompt advice after two consecutive fouls, in the second and third rounds, in Bhubaneswar. Sreeshankar said, "I'm verv happy for Shahnavaz, he did above 8 metres. He's very young. We train together, we push each other. And we have a very good rapport." Shahnavaz is rubbing shoulders with the best now but his early inspiration was his cousin Shahruk Khan, the Under-20 3,000 metres steeplechase national-record holder. "I picked up the long jump because I found jumping to be more easy than running. Running has never been easy for me," Shahnavaz said.

With his first-ever international medal in the bag, Shahnavaz is dreaming big. "I want to represent India at every major competition like the Olympics, Asian Games and Commonwealth Games. The 8metre jump has given me confidence," he said.

However, Shahnavaz has a grouse — he is yet to receive the prize money for winning the National Games gold. His mother runs the house, while his younger sister and brother are still in school. "My mother looks after the house and also works in the fields. That is how she manages to run the household. Every penny is important for our family. It has been more than six months since I won the gold medal at the National Games representing UP but I haven't got the prize money announced for gold-medal winners." The silver at the Continental Tour event, Shahnavaz hopes, paves the way for more prize

money and bigger medals.

The remarks came as Senior Advocate A M Singhvi, appearing for some petitioners, told the bench that it was not within the EC's remit to decide on citizenship. Singhvi also questioned the EC's reluctance to consider Aadhaar and Electoral Photo Identity Cards (EPIC), saving it's "very clear that EC does not want to look at them because they say it's insufficient for determining citizenship. Otherwise, there's no reason." Justice Kant said the Aadhaar

Act states that it's not proof of citizenship, "One is furnishing of documents, second is verification. Today, if I attach a fake Aadhaar or a fake ration card, they have a right to verify," he said. Senior Advocate Kapil Sibal,

also appearing for some petitioners, said prima facie there is an assumption that these are valid doc-"Yes, but if you attach a docu-

ment, it requires consideration, verification," said Justice Kant. This entire exercise is with-

out jurisdiction. Because the EC has converted itself into an agency that flags citizenship," Singhvi said. "My proposition is determination of citizenship is an exercise which does not fall in the EC's domain at all. They can't say, two

months before a 9-10 (voters)crore election, we are doing SIR and we will remove you on grounds of citizenship. It is true that you have to decide citizenship to be on the roll. But 5 crore people are already in the roll after 2003 (revision). Their removal on grounds of citizenship or lack of it has to follow a procedure which is not with them...The argument is that from 2003-2025, there is presumptive exclusion" unless the EC, on the basis of its test, finds them to be citizens, he said. "Presumptively you are held not to be a citizen till you show other-

"They (EC) admit that no inquiry was conducted to ascertain whether these people (who were not included in the draft roll on the ground of death, migration to other places etc) are indeed dead or migrated," Sibal said. These are people who were there in the 2003 rolls drawn up after a revision, he said, adding, "and since then 22 lakh have died." In a press release on July 27, the

EC had said that of the 7.89 crore electors who were registered as on June 24, 7.24 crore had been included in the draft roll, 22 lakh had died, 36 lakh had either permanently shifted or were not found, and 7 lakh were enrolled in multiple places.

"There is a degree of intensity in a summary revision vis-a-vis an intensive revision. So inclusion in

a summary revision role does not give you carte blanche to be in an intensive revision draft roll,' Justice Bagchi said. "Electoral roll is presumptively

held not to be valid solely on grounds of citizenship. You cannot have a system where citizenship is doubted for 5 crore people... presumption is he's a valid citizen unless they follow procedure and remove," Singhvi said. "Up to 2003, there's no dis-

pute. Those who are on voter list, they are not required to submit any documents. Mr Dwivedi is saying those who were voters till 2003, their children also are not required to give documents," Justice Kant said, referring to Senior Advocate Rakesh Dwivedi who was appearing for the EC. "When elections are two-and-

a-half months away... they have issued a presumptive negative declaration... Look at the object of all this. You declare 5 crore people to be not valid and give them twoand-a-half months," Singhvi said. "If they declare 5 crore people

invalid, we are sitting here. We would definitely like to examine,' Justice Kant said. Praying for interim relief,

Singhvi said: "We estimate that if you ask for certificates...maybe 1 (crore), maybe 2 crore will be invalid. Now we can't wait till we come back in September and Your Lordships is told the Model Code of Conduct is in force, elections are

around the corner. They are in a scrambling mode.

Iustice Kant said the process can be invalidated even in September if the court finds it is not lawful. "So what? Can't we set it aside even in September, even if we have a lurking suspicion about the procedure followed by the EC." he said.

Referring to those who have been left out of the draft roll, Advocate Prashant Bhushan, appearing for the Association for Democratic Reforms (ADR), said the EC, in its affidavit, had said, it had "given some of this information to the Booth Level Agents (BLAs) of recognised political parties. They say they are not obliged to give to anyone else.' "Today, what they have done

is something mischievous. Until August 4, the draft of the roll was searchable. After August 4, the document is not searchable. They say, go and ask the BLAs of the political party. Why should I, as a citizen, not know from their document and ask an agent of the political party," he asked.

"Voters and all bona fide citizens have a right to know," Justice Kant said. Dwivedi said ADR had filed a

"speculative petition" and "must await the completion of the exer-Activist Yogendra Yadav, who

also addressed the court, said: "This is the first revision exercise in the whole country where there is zero addition and there are only omissions." He said Bihar has 8.18 crore adult population and there should be more voters, but 65 lakh had been excluded. He contended that mass disenfranchisement has

already taken place with their ex-"With one stroke, the percentage of adults eligible to vote in ready. There would be further deletions now," he said, adding that the number of women vot ers who have been excluded was more than men.

Yadav also produced before the bench a man and a woman, who, he said, had not made it to the draft rolls as they had been declared dead. "They have Aadhaai card, EPIC card, they have been declared dead," he told the bench.

Objecting, Dwivedi said the claims were being made without any evidence. "This drama is good for anchoring. Keep it for the TV,"

Justice Bagchi told Yadav: Your points are well taken, but these instances may be inadvertent errors which can be corrected." Justice Kant compli mented Yadav, saying, "Excellent analysis... we may partly agree, we may 100 per cent agree, that's a different issue. But a very good

The court will continue to hear the case on Wednesday.

### • EC's use of 'notional' house numbers

10,452 were "bulk voters" registered at common addresses. Examples included entries with "0" in the address field, non-existent locations and addresses that could not be verified.

For much of India's electoral history, the electoral rolls were simple lists with only the elector's name, age, a relative's (father, mother or husband) name, constituency and serial number. While the "house number" column was there, it was often left blank. Some pages of the rolls from 1980, 1983 and 1988 examined by The Indian Express list only the serial number, name, gender and age in most cases, with house numbers given for some electors. However, some of these house numbers were notional, they were known as "temporary house number", an official said.

The EC began computerising the rolls in 1998 and introduced photo electoral rolls in 2005, according to its 2023 Manual on Electoral Rolls. It was during this shift to digital records that the practice of assigning "notional" addresses became standard across the board, ensuring that electors without a permanent or well-defined address — or those who left the field blank — were not excluded from the database. The problem of inconsistent or

informal addresses goes beyond the drafting or revision of electoral rolls. The Centre has acknowledged it as a long-standing challenge - most recently in May, when the Department of Posts, in a policy document, proposed creating a digital public infrastructure to standardise addresses. "Despite the centrality of address information in everyday life, frictions exist in how such data is managed, shared and used across India," it noted, citing linguistic diversity, inconsistent formats and fragmented address data. Current and former Election

Commission (EC) officials told The *Indian Express* that over time, when electors either lacked a proper address or left the field blank, they were assigned "notional" addresses to ensure their inclusion in the rolls. EC instructions dating back to at least 2011 and reiterated as recently as June 24 for the ongoing Special Intensive Revision (SIR) in Bihar direct that such numbers be allotted and clearly marked as "notional" in the roll. Identical wording appeared in instructions to Chief Electoral Officers of pollbound states, including Chhattisgarh, Madhya Pradesh, Mizoram, Rajasthan and Telangana, in May 2023.

Officials said the practice exists nationwide, but tends to draw greater attention in urban constituencies with high migrant populations and unplanned settlements. It stems from the Commission's stated philosophy of inclusion, not exclusion, from the electoral roll. For example, in the case of homeless persons, EC guidelines instruct Booth Level Officers (BLOs) to verify the address given in Form 6 at night – checking on more than one occasion — to confirm that the person actually sleeps there. No documentary proof of residence is required if this is established.

A 2011 EC training module for BLOs stated that where a municipality has assigned house numbers, those should be used, as they also appear on Electors Photo Identity Cards (EPICs) that double as address proof for other government schemes. Where no official number exists, or the sequence is irregular, BLOs are to assign notional numbers starting from 1 in manual noted, are "computer generated" and "not necessarily in consonance with the number allowed by the municipality". ities sometimes allot "0" as a house number to avoid conferring legal status, an official said. It is unclear whether this was the case in the addresses Gandhi cited.

A former CEC said the quality of rolls has improved over the years and a notional address was not an irregularity. Similar objections had surfaced earlier - during the 2023 Telangana Assembly elections, the BIP flagged voters listed with "0" as their house number. In the Bihar draft rol published on August 1, the use of notional numbers has continued.


