# Bhagwat: Can't put all Muslims in bracket, have to see good & bad

**Express News Service** Bengaluru, November 9

SARSANGHCHALAK Mohan Bhagwat said on Sunday that majority of Muslims in the country did not approve of 'love jihad' or Ghazwa-e-Hind (an alleged holy war against India), but there was also a sizable section of 'kattarpanthis' (fundamentalists) in the community. "Good people, we have to segregate from the mob of bad people," he said in Bengaluru while responding to questions during the 'New Horizons' lecture session held to mark the centenary year of the RSS.

"...the 'sanskar' in our households, the 'maryada' of behaviour...Giving them to our children is our responsibility. We have faltered and the result is (the) success of 'love jihad'. Secondly, don't put everybody into(a) single bracket," he said. adding that there is a section among Muslims that deplores the perpetrators of Ghazwa-e-

Hind and 'love jihad'.

'We should know them. We should keep them in contact," Bhagwat said. The RSS chief said even as there is a "sizeable section of fundamentalists", we put the entire Muslim community in one bracket whenever instances of 'love iihad' or other such happenings surface. "That is not good. We are Hindus, we don't think like that," he said, adding that the number of funtire community is blamed.

"Sama neeti" (policy of conciliation) is required. We have to fortify ourselves, so, 'dand neeti' (policy of punishment) is also required... Good people,

mob of bad people... There should be a distinction between the good and the bad. They should be separated. We can't treat everyone equally. Treatment should be different for different people. We should do this," he told the gathering.

controversy over RSS registration in Karnataka. This is not the first time the question is raised, he said, asking whether anyone expected it to register with the British government in 1925. "After Independence, the laws did not make registration compulsory. We are categorised as (a) body of individuals. We are (a) recognised organisation," he said.

He brushed aside the recent

Recalling a court judgement after the Income Tax Department asked RSS to pay taxes, he said that the court recognised it as "a body of individuals and our 'guru dakshina' was exempted from the income tax. We were banned thrice. Each and recognised RSS as a legal organisation," Bhagwat said.

On Karnataka Minister Priyank Kharge's recent pitch for regulating RSS activities in the state, Bhagwat said: "We need not answerthem. We have other important work to do... The criticism makes us more famous. We have just witnessed (it) here in Karnataka. We will encourage them to raise more questions." On whether the RSS would

hold outreach programmes for minorities, he said, "No Brahmin is allowed in Sangh. No other caste is allowed in Sangh. No Muslim is allowed... No Christian... No Shaiva... Only Hindu is allowed. People with different denominations, Muslims... Christians can come to Sangh... Your speciality is welcome. But, when you come inside 'Shakha', you come as the son of 'Bharat Mata'.... a member of the broader Hindu society," he said.

## CJI says legal aid not act of charity, but moral duty

New Delhi, November 9

CHIEF JUSTICE of India B R Gavai Sunday said that "legal ity but moral duty" and "an exercise in governance, in ensuring that the rule of law extends to every corner of our country".

At the Valedictory Function of the National Conference on 'Strengthening Legal Aid Delivery Mechanisms', organised by National Legal Services Authority (NALSA), the CJI said that the "legal aid movement stands as one of the finest expressions of our Constitution's soul, as a bridge between the letter of law and the lived

NALSA Executive Chairman and CJI-designate Justice Surva Kant, addressing the event, said, "the notion of 'access to justice' is not an abstract ideal but rather a sapient right that must be continuously nurtured through institutional strength, professional competence, and compassionate engagement.'

Justice Kant said NALSA has evolved "from a statutory body into asymbol of constitu-

The CJI said that "Legal Services Authorities should actively collaborate with academic institutions, research organisations, and professional bodies to conduct periodic social audits of our schemes and interventions" as "such partnerships can help... assess not only how many people we have reached, but how deeply and meaningfully our interventions have improved their lives".

Underlining the need for a long-term shared institutional vision while conceiving and executing legal services author-

present, much of our planning is often shaped by the tenure and priorities of individual Executive Chairpersons, each of whom may have only a limited period to conceptualise and implement initiatives". He added that "while this brings diversity of ideas, it also makes continuity and sustained implementation a challenge".

To address this, the CJI sug gested "creation of an Advisory Committee at NALSA and SLSAs (State Legal Services Authorities) respectively, com prising the current Executive Chairpersons and two or three future or incoming Executive could meet quarterly or every six months to discuss and over see projects with a long-term perspective".

"Such an arrangement", he said, "would help institutionalise vision-based planning and ensure that key programmes whether related to access to justice, awareness, or digital trans formation, are carried forward consistently, regardless of ad ministrative changes.

The CJI pointed out that while "judicial training often teaches" judges "to maintain a certain distance, to weigh evidence dispassionately, and to apply reasoned judgment. the work of legal aid demands the opposite sensibilities: empathy collaboration, and ability to see beyond procedure into the con ditions that produce injustice"

Recalling his visit to Ma nipur, where ethnic clashes erupted in May 2023, as Executive Chairman of NALSA along with some colleagues, CJ Gavai said, "We went to both the refugee camps of Meiteis and Kukis, and we are happy to see a smile on their faces.

PRESIDENT DROUPADI Murmu, during her maiden visit to Angola as the Indian head of state, has said that energy cooperation is the foundation of trade ties between the two countries.

"Our economic partnership is based on a vibrant energy partnership. We agreed to further diversify trade and investment relations in new areas, including technology, agriculture, health, defence, infrastructure, and people-to-people ties,' she said in a statement.

Murmu held bilateral talks with her Angolan counterpart João Lourenço in Luanda. Earlier, she was accorded a grand ceremonial welcome and Guard of Honour at the Presidential Palace in Luanda upon arrival. The two leaders held comprehensive talks aimed at deepening the multifaceted partnership between India and Angola. curity Council (UNSC). During the discussions,

President Murmu emphasised the importance of expanding cooperation across a wide range of sectors that reflect both nations' shared priorities and complementarities. She highlighted potential collaboration in areas such as sharing of parliamentary best practices. agriculture-especially in seeds and fertilizers-oil exploration and refining, connectivity and transport infrastructure, rare earth minerals, and diamond processing.

The President underscored India's specific expertise in several of these domains and conveved India's readiness to work closely with Angola in harnessing these opportunities for mutual growth and prosperity. She also placed a strong focus on capacity building and training. digital public infrastructure, defence cooperation, and reforms of the United Nations Se-

Lauding Angola's commitment to sustainable development. President Murmu congratulated the country for joining two major global initiatives led by India — the Global Biofuels Alliance and the International Big Cat Alliance underscoring Angola's proactive role in addressing global environmental and biodiversity challenges. The two sides are scheduled to sign and exchange several Memoranda of Understanding (MoUs) to formalise cooperation in identified sectors.

Murmu is on a four-day state visit to Angola, the first by an Indian President. India is among the top three trading partners of Angola for some vears, and currently it is second after China, sharing about 10% of Angola´s external trade, as per official statistics reported by the MEA.


