POLICY FOR DETERMINATION OF MATERIALITY OF EVENTS OR INFORMATION
FOR DISCLOSURE

1. PREAMBLE

In terms of Regulation 30 (1) of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 as amended from time to time (“**SEBI LODR Regulations**”), every listed entity shall make disclosures of any events or information which, in the opinion of the Board of Directors of the listed company, are material.

Regulation 30 (4) (ii) of SEBI LODR Regulations requires framing of a policy for determination of materiality, based on criteria as laid in the Regulations, duly approved by its Board of Directors, which is disclosed on its website.

Accordingly, the Board of Directors (the ‘Board’) of NTPC Limited (‘NTPC or Company’) had adopted the policy and procedures as “NTPC Policy for Determination of Materiality of Events or Information for Disclosure” (the ‘Policy’) for disclosure of material events or information to the stock exchanges, which are considered necessary from time to time. The said policy has been modified subsequently after the amendments in applicable provisions.

2. PURPOSE

This policy is framed as per requirements of SEBI LODR Regulations for timely, adequate and accurate disclosure of information on an ongoing basis by the Company to enable investors to make well-informed investment decisions.

3. INTERPRETATION:

Words or Expressions used in this policy shall have same meaning as given under the SEBI LODR Regulations or under the Companies Act, 2013. Further, in case of inconsistency between any provision(s) of this policy with any existing policy(ies) of the Company, provisions of Policy for Determination of Materiality of Events or Information will prevail.

4. DISCLOSURE:

In terms of Regulation 30 of the Listing Regulations, the events requiring disclosure by the Company are provided as follows:.

Annexure-I	Events which are deemed to be material events and have to be disclosed to the Stock Exchange without application of criteria of materiality as defined in clause 5 of this policy.
Annexure-II	Events which are disclosed by the Company on application of criteria for materiality as defined in clause 5 of this policy.
This Policy shall also apply to the events which are not indicated in Annexure-I or Annexure-II, but may have a material effect on the company.	

Further, where the Company makes disclosures to the Stock Exchanges as per Annexures referred above, the Company will also disclose material developments, as may be decided by the Competent Authority on a regular basis.

5. TEST OF MATERIALITY:

In order to determine whether a particular event / information is material in nature, the following 'quantitative' or 'qualitative' criteria(s) shall be applied:

- a) Quantitative Criteria:** Unless otherwise the limits expressly provided under any clause in the Policy and Annexure attached thereto or under any provision of SEBI LODR Regulations, any event or information, shall be considered material if its value or the expected impact in terms of value, exceeds the lower of the following:
- i. two percent of turnover, as per the last audited consolidated financial statement of the Company.
 - ii. two percent of net worth, as per the last audited consolidated financial statement of the Company, except in case the arithmetic value of the net worth is negative.
 - iii. five percent of the average of absolute value of profit or loss after tax, as per the last three audited consolidated financial statement of the Company.
- b) Qualitative Criteria:** In absence of quantitative criteria, event shall be considered as material if ;
- i. the omission of an event or information, which is likely to result in discontinuity or alteration of event or information already available publicly; **or**
 - ii. the omission of an event or information is likely to result in significant market reaction if the said omission came to light at a later date.
 - iii. event or information as may be decided martial by the Competent Authority or Board of Directors.

In case where the criteria specified hereinabove is not applicable, an event or information may be treated as being material if in the opinion of the Board of Directors of the Company, the event or information is considered material.

6. COMPETENT AUTHORITY FOR DETERMINATION OF MATERIALITY OF EVENT/INFORMATION OR MATERIAL DEVELOPMENT

As required under the Regulation 30 (5) of the SEBI LODR Regulations, the Chairman & Managing Director and Director (Finance) shall severally be the Competent Authority to decide materiality of an event /information or development for the purpose of making disclosure to the Stock Exchange.

7. PROCEDURE FOR DISCLOSURE:

The concerned Head of Department/ Project in consultation with concerned Executive Director/ Functional Director shall prepare a draft, which shall be forwarded to Company Secretary or the Officer nominated as per Code of Practices and Procedures for Fair Disclosure of Unpublished Price Sensitive Information for taking approval of Director (Finance) or Chairman & Managing Director. The draft should contain information as per SEBI LODR Regulations and circular No. SEBI/HO/CFD/PoD2/CIR/P/ 0155 dated 11th November, 2024 or other applicable circular/notification etc. issued by SEBI or any other authority and modified from time to time or any other statute as may be necessary to enable investors to make well-informed investment decisions.

All Head of Department/ Project of the Company shall be under an obligation to make disclosure as laid down in this Policy and Schedule III of the SEBI Listing Regulations and shall immediately forward to Compliance officer, in order to adhere the stipulated timelines under SEBI LODR regulations. In case of any delay in intimation, reasons for delay shall also be communicated to the Compliance Officer for onward submission to Stock Exchanges.

After approval of the competent authority, Company Secretary or the Officer nominated as per Code of Practices and Procedures for Fair Disclosure of Unpublished Price Sensitive Information shall make adequate disclosure of the said event/ information to the Stock Exchanges on the basis of content received and as per the timeframe defined in this Policy and the SEBI Listing Regulations.

8. HOSTING ON WEBSITE:

All the above disclosures will be hosted on the website of the Company for a minimum period of five years.

9. AMENDMENTS

The Chairman & Managing Director may, subject to the applicable laws, amend any provision(s) or substitute any of the provision(s) with new provision(s) or replace the Policy entirely with a new Policy. However, no such amendment or modification shall be inconsistent with the applicable provisions of any law for the time being in force.
